THE HOLY SPIRIT AS ADVOCATE

The shy person?

The Holy Spirit is sometimes called "the shy person of the Trinity" because He is all about testifying to Jesus and not Himself. The Holy Spirit's primary purpose is to convince us of the truth of who Jesus is, what He has taught and what He has done. Note that the Holy Spirit is so closely aligned with advocating the truth about the Son that Jesus even calls Him "the Spirit of truth". "When the *paraclete* comes, whom I will send to you from the Father, the Spirit of truth that comes from the Father, he will testify on my behalf" (John 15: 26; see also 14:16 and 16: 13).

The Holy Spirit is not about giving us some new revelation. Rather, He is all about bringing to mind and being at work in the previous revelation of God in Christ. "The *Paraclete,"* Jesus says, "...will teach you everything and remind you of all that I have said to you" (John 14: 25). Just as the Son speaks and acts in accord with the words and works of the Father (John 5: 19; 3: 34), so also the Holy Spirit testifies to the words and works of the Son. This is what Jesus teaches: "When the Spirit of truth comes, he will guide you into all the truth, for he will not speak on his own authority, but whatever he hears he will speak, and he will declare to you the things that are to come. He will glorify me, for he will take what is mine and declare it to you" (John 16: 13-14).

The Advocate at work

So, how does one see or hear the Holy Spirit's work today? Look to where truthful testimony about Jesus is offered, and you will hear the Spirit of truth at work. What if someone claims that a new truth has been revealed to them by the Holy Spirit? The Holy Spirit has been active speaking through the prophets, the evangelists and apostles, and has spoken in the ultimate way in Jesus' preaching and teaching (Heb. 1: 1-2). He does not and will not contradict what He has spoken through these individuals in the past.

A true Christian who is "filled with the Holy Spirit" is not one who speaks about the Holy Spirit all the time, but one who testifies to who Jesus is and what he did. That is the work of the spirit in us. A true Christian congregation empowered by the Holy Spirit is not one that constantly speaks about the Holy Spirit, but one that testifies to who Jesus is and what he did. That is the work of the Spirit in the Church.

As Jesus taught, "He will glorify me, because he will take what is mine and declare it to you" (John 16: 14). We not only have the Son as our advocate with the Father, but we also are blessed with the Holy Spirit as our advocate for the Son, Jesus Christ, as He works through Baptism, the Lord's Supper and the Word of God to unite us in faith to Jesus, through whom we receive the abundant and eternal life that climaxes in the resurrection of the body on the last day.



FOUR TRUTHS ABOUT PARENTAL RIGHTS

What does the Bible say about parental rights?

Truth #1 Children belong to God.

Psalm 127:3 says, "Behold, children are a heritage from the Lord, the fruit of the womb a reward." In order to define parental rights, we must understand that children ultimately belong to God; they are human beings created in His image.

Truth #2 God has entrusted children to their parents.

If children belong to God, to whom has He entrusted the sacred task of raising them? The command for children to honor their father and mother (Exodus 20:12), the exhortation to listen to their father and mother's instruction (Proverbs 6: 20), and the charge to parents to teach their children and "bring them up in the discipline and instruction of the Lord," (Ephesians 6: 4) are a few Scriptures showing that **parents** are the ones charged with raising their children. This charge is **not** given to the government.

Truth #3 Parents are accountable to God for the way they raise the children entrusted to them.

The fact that God has entrusted children to parents is not a license for abuse or neglect. The Bible is clear that we are accountable to God for everything entrusted to our care — how much more does this apply to the children entrusted to parents! In *true* cases of abuse or neglect, God has given the state authority to defend that child and "punish those who do evil" (I Peter 2: 14). However, it must not misuse that authority to punish good parents; that is evil itself.

Truth #4 Parents have the right and responsibility to raise their children and direct their education.

Because God has given children to parents, it follows that parents are the primary decision-makers when it comes to their child's upbringing, including their education. While they may choose to *contract* with schools to facilitate their child's learning, they are ultimately responsible for the physical, intellectual, and spiritual growth of their child. Decisions about what, how, when, and where their child will be taught, as well as who will teach them, should be theirs to make.
